Limited Warranty:

Subject to the terms and conditions stated herein, **Jerry Huber & Associated, Inc.** (hereinafter) “**Supplier**” warrants the edge glue, face glue and finger joints from glue failure of **ALLPRIME** products for a period of 10 years from date of purchase to the original consumer purchaser. This warranty may not be transferred or assigned.

Each purchaser of **ALLPRIME** products is responsible for following generally accepted practices for finished lumber and **Supplier** guidelines for storage, handling, installation, and finishing of the **ALLPRIME** products. **ALLPRIME** products are not for structural use or load bearing applications. **ALLPRIME** products must be kept clean and dry prior to application of the finish paint coat or coats. The installer or consumer must prime coat any cut ends and any areas around fastening devices. i.e.: nails, screws, staples, etc. with 100% Acrylic Latex primer or Alkyd Oil primer. Failure to follow above recommended guidelines will void this warranty.

Limitations/Exclusions

The warranty is limited exclusively to replacement of defective **ALLPRIME** product only. In no event shall the **Supplier** be liable for mold growth, paint or coating failure, labor, installation, removal, re-installation, freight, taxes, or any other charge related to a defective **ALLPRIME** product.

Additional Limitations

Supplier shall not be liable for any indirect, incidental, punitive, consequential, exemplary or other damages of any kind whatsoever, whether any such claim is based upon theories of contract, warranty, negligence, tort strict liability or otherwise. This Limited Warranty does not cover and the **Supplier** is not liable for damage or failure of the **ALLPRIME** product as a result of one or more of the following: intentional or unintentional misuse of or damage to the **ALLPRIME** product; impacts of foreign

objects; earthquake, flood, fire, excessive heat, lightning, hail, ice, tornado, hurricane, windstorm, or any other Acts of God; improper installation of **ALLPRIME** or its structural or non-structural supports and accessories used in connection with, or not in strict adherence to **Supplier's** Product Storage and Finishing recommendations; movement, settlement, distortion, warping or cracking of the **ALLPRIME** product's structural or non-structural support or accessories used in connection therewith; physical abuse, vandalism, riot, insurrection, improper maintenance, use of incompatible accessories; or other products that cause an **ALLPRIME** product defect or failure to occur; pollution, acid rain, application of harmful chemicals, gas or vapors applied to the **ALLPRIME** product; or ordinary and expected weathering due to exposure to the elements or extreme atmospheric conditions that may be unique to a certain geographic area. The **Supplier** shall have sole discretion in the determination of **ALLPRIME** product suffering from normal weathering. This warranty does not cover painted finishes or coatings applied to **ALLPRIME** products by the original purchaser or any third party.

All claims under this Limited Warranty must be made within 60 days from the time the defect is discovered and while the **ALLPRIME** product is in place. The **Supplier** reserves the right to inspect and test any defective **ALLPRIME** products, their installation, and the environment in which it was used. The **Supplier** shall have the option of retaining all material if replaced. No dealer or other person or entity is authorized by the **Supplier** to make statements or representations regarding the performance of the **ALLPRIME** product except as contained in this Limited Warranty and the **Supplier** shall not be bound by any such statements other than those contained herein.

How to File a Warranty Claim
